

Viamerica's Presents the Win a Tablet Sweepstakes (the "Sweepstakes")

OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.

OPEN ONLY TO RESIDENTS OF ARKANSAS, ARIZONA, CALIFORNIA, DELAWARE, FLORIDA, GEORGIA, ILLINOIS, INDIANA, KANSAS, KENTUCKY, LOUISIANA, MARYLAND, MINNESOTA, MISSOURI, NORTH CAROLINA, NEW JERSEY, NEVADA, NEW YORK, OHIO, OKLAHOMA, OREGON, PENNSYLVANIA, SOUTH CAROLINA, TENNESSEE, TEXAS, VIRGINIA, WASHINGTON AND WISCONSIN (AS EVIDENCED BY HOME ADDRESS AT THE TIME OF ENTRY). - 1.
