

Viamericas Presents the “Viamericas Ramadan 2024” Sweepstakes 2024 (the “Sweepstakes”)

OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.

OPEN ONLY TO RESIDENTS OF THE UNITED STATES OF AMERICA (AS EVIDENCED BY HOME ADDRESS AT THE TIME OF ENTRY). VOID WHERE PROHIBITED BY LAW.

1. **ELIGIBILITY REQUIREMENTS:** Open to residents of the United States of America, who are 18 years of age or older at time of entry. Limit of one (1) entry per person. Automated means of entry are prohibited, and any use of automated devices will cause disqualification. 4. **SWEEPSTAKES DRAWING, ODDS, PRIZE, AND MAXIMUM VALUE:** Winners will be selected in a random drawing by Viamericas from all eligible entries received. Odds of winning depend on the number of eligible entries received; purchase will not enhance odds of winning.
