

Viamericas Presents the “Viamericas Mother’s Day In-Store Sweepstakes” Sweepstakes 2024 (the “Sweepstakes”)

OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.

OPEN ONLY TO RESIDENTS OF THE UNITED STATES OF AMERICA, (AS EVIDENCED BY HOME ADDRESS AT THE TIME OF ENTRY), EXCEPT FOR FLORIDA, NEW YORK, RHODE ISLAND AND WHERE PROHIBITED BY LAW.

1. **ELIGIBILITY REQUIREMENTS:** Open to legal residents of the United States of America, who are 18 years of age or older at time of entry, except residents of Florida, New York, Rhode Island and where prohibited by law. Employees, contractors, directors and officers of Viamericas, and the immediate family members of each such person (spouse, parent, child, sibling, grandparent, and spouse or "step" of each) and those living in the same household of each such person (those persons whether related or not who live in the same residence for at least three months during the twelve-month period preceding the start date of the Sweepstakes) are not eligible to enter or win. By participating, entrants agree to abide by and be bound by these Official Rules.
2. **SWEEPSTAKES PERIOD:** Sweepstakes begins on April 15, 2024, at 00:00:01 AM Eastern Standard Time and ends May 15, 2024, at 11:59:59 PM Eastern Standard Time (the "Sweepstakes Period"). The Web Site server is the official clock for this Sweepstakes. The Sweepstakes drawing will be held on May 20, 2024.
3. **TO ENTER:** There are two (2) methods of entry for this Sweepstakes: (1) Complete a money transfer transaction at any participating Viamericas agent by sending money to be paid out by any Viamericas Pay-Partner; or alternatively (2) you may print your name, street address, daytime telephone number, mobile phone number, email, and the letters "Viamericas Mother’s Day In-Store Sweepstakes 2024" on a 3" x 5" plain index card and mail to: Viamericas, c/o Sweepstakes, 2100 Ponce De Leon Boulevard PH-2 Coral Gables, FL 33134.

Limit of one (1) entry per person. Automated means of entry are prohibited, and any use of automated devices will cause disqualification. Entrants may not use any other device or artifice to register multiple times or as multiple entrants. Any participant who uses any device or artifice to enter multiple times will be disqualified and forfeits any and all prizes won, at Sponsor’s sole discretion. Proof of submission of an entry does not constitute proof of delivery or entry.

4. **SWEEPSTAKES DRAWING, ODDS, PRIZE, AND MAXIMUM VALUE:** Winners will be selected in a random drawing by Viamericas from all eligible entries received. Odds of winning depend on the number of eligible entries received; purchase will not enhance odds of winning.

Enter to win one (1) of the following prizes, at the discretion of the participating Viamericas agency: a 40" television (154 total) with an Approximate Retail Value (“ARV”) of \$185 USD each, two (2) \$100 restaurant gift cards (30 total) with an ARV of \$100 USD each (total ARV \$200), or a Go Stream 14” Laptop (84 total) with an ARV of \$190 USD each.
