

Viamerics 2024 Mid Central Father's Day Sweepstakes (the "Sweepstakes")

OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.

OPEN ONLY TO KANSAS, MISSOURI, LOUISIANA, MISSISSIPPI, NEBRASKA, IOWA, ARKANSAS, AND OKLAHOMA STATE RESIDENTS (AS EVIDENCED BY HOME ADDRESS AT THE TIME OF ENTRY). VOID WHERE PROHIBITED BY LAW.

1. **ELIGIBILITY REQUIREMENTS:** Open to legal residents of the states of Kansas, Missouri, Louisiana, Mississippi, Nebraska, Iowa, Arkansas, and Oklahoma, who are 18 years of age or older at time of entry, except where prohibited by law. 3. **TO ENTER:** There are two (2) methods of entry for this Sweepstakes: (1) To be automatically enrolled, complete a money transfer transaction at any participating Viamerics agency; or alternatively (2) you may print your name, mailing address, phone number, email, and the letters "2024 Mid Central Father's Day Sweepstakes " on a 3" x 5" plain index card and mail to: Viamerics, c/o Sweepstakes, 2100 Ponce De Leon Boulevard, PH-2, Coral Gables, FL 33134. All write-in entries must be postmarked by July 10, 2024 and received by August 13, 2024. There is a limit of one (1) write-in entry per envelope/postcard.

Limit of one (1) entry per person. Automated means of entry are prohibited, and any use of automated devices will cause disqualification. Entrants may not use any other device or artifice to register multiple times or as multiple entrants. Any participant who uses any device or artifice to enter multiple times will be disqualified and forfeits any and all prizes won, at Sponsor's sole discretion. The Sweepstakes drawing will be held on July 15, 2024. Odds of winning depend on the number of eligible entries received; purchase will not enhance odds of winning.

The total ARV of all prizes is \$585 USD (together the "Prizes"). Winners are not permitted to substitute prizes, nor can the prize be exchanged for cash.
