

**Viamericas' Indus Fast Remit 2024 T20 Cricket World Cup Ticket Giveaway
("Giveaway")**

OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.

OPEN ONLY TO RESIDENTS OF THE UNITED STATES OF AMERICA, EXCEPT THOSE RESIDENTS IN RHODE ISLAND (AS EVIDENCED BY HOME ADDRESS AT THE TIME OF ENTRY). VOID WHERE PROHIBITED BY LAW.
